Subject:- Revised syllabi for the subjects of Workshop Calculation & Science and Engineering Drawing for the trades under Craftsmen Training Scheme (CTS)- Regarding.

Sir/Madam,

The NCVT has approved implementation of the different syllabus for Workshop Calculation & Science and Engineering Drawing for engineering trades having entry qualification of 8th and 10th passed and also formation of group of trades for W/Sh. Calculation & Science and Engineering Drawing syllabi for the Semester- III & IV. The same was intimated to all the concerned vide letter no. **MSDE-19/3/2015-CD** dated **17.08.2015** (copy enclosed). All the revised syllabus of W/Sh. Calculation & Science and Engineering Drawing are available on www.dgt.gov.in and the same will be followed for AITT to be held in January/February, 2016 for all engineering trades in **Semester- III** including Mentor Council trades. As there is no change in the syllabi for trainees W/Sh. Calculation & Science and Engineering Drawing for Sem-IV, the question paper for **Sem-IV** for the subject W/Sh. Calculation & Science and Engineering Drawing will be conducted as per the syllabi based on 2013 for all engineering trades.

Regarding the trainees admitted in August, 2013, 2014 & 2015, the separate syllabi for the subject W/Sh. Cal. & Sci. and E.D. for all engineering trades under CTS with entry qualification as 10th Pass for semester-I & II had been already approved in 2014. Similarly, for all engineering trades under CTS with entry qualification as 8th pass for **semester-I & II** syllabus of W/Sh. Cal. & Sci. and Engineering Drawing has been approved vide letter no. **MSDE-19/3/2015-CD** dated **17.08.2015**. Accordingly, there will be one common paper of W/S. Calculation & Science and one common paper of Engineering Drawing for trades with 8th pass entry qualification and similarly for 10th Pass entry qualification also for Sem-I and Sem-II including Semester and Mentor Council trades.

The above is once again clarified as:- **Syllabi to be followed for subject W/Sh. Cal. & Sci. and Engineering Drawing for all engineering trades for AITT under CTS to be held in February, 2016:-**


- (a) **Semester-I & II** (Semester & Mentor Council) for Ex and Regular trainees, admitted in session- August, 2013, 2014 & 2015:-
- (i) **Entry qualification 8th pass-** One common paper of W/Sh. Cal. & Sci. and one common paper of Engineering Drawing.
 - (ii) **Entry qualification 10th pass-** One common paper of W/Sh. Cal. & Sci. and one common paper of Engineering Drawing.

- (b) **Semester-III** (Semester & Mentor Council) for Ex and Regular trainees, admitted in session August, 2013, 2014 & 2015:- Grouped syllabi of different trades, revised in 2015 and question papers will be supplied accordingly.
- (c) **Semester-IV** (Semester) for Ex trainees, admitted in session August, 2013:- No change in the syllabi and question papers will be supplied accordingly.

In view of above, you are requested to instruct all the concern in your respective State to follow the revised and grouped trade syllabi of W/Sh. Cal. & Sci. and E.D. for **Sem-III** and follow the syllabi of W/Sh. Cal. Sci. and E.D. revised in 2014 for **semester-I & II**. The forthcoming AITT under CTS will be conducted for W/Sh. Cal. & Sci. and E.D. as per the revised syllabi in August, 2014 and 2015.


